The mathematical aspect of beam vibrations is discussed in detail, and the different types of vibrations are also explained. The

book gives a comprehensive discussion of the reactions of beams to moving loads; the vibrations of beam systems; and the beams on elastic foundations. The second part of the book focuses on the vibrations of plates and shells. In this section, an introduction is given to vibrations of rectangular and circular plates.
