The third crucial element is found in an institutional arrangement—the distinctively American matrix of governmental institutions, which converts those first two elements into a framework for policymaking, year in and year out. Recent policy conflicts and institutional combatants, in Shafer's analysis, illuminate this new pattern of American politics.
